WELCOME TO COUNTRY 500 - THE GREAT AMERICAN MUSIC FEST AT DAYTONA!

ALL BAGS WILL BE SUBJECT TO SEARCH UPON ENTERING THE FESTIVAL
FOR YOUR FUN AND SAFETY, PLEASE OBSERVE THE FOLLOWING:

YES

- Small bags, backpacks & cinch bags
- 12-pack or smaller soft coolers
- Factory-sealed bottled water for personal consumption
- Single, collapsible chairs
- Wheelchairs, medical scooters
- Push strollers for children
- Small pole-style umbrellas (under 63")
- Blankets or beach towels
- Sunscreen (including aerosol)
- Ice in permitted bag/soft cooler
- Empty plastic bottles and CamelBaks
- Cigarettes & lighters
- E-cigs
(mid-sized e-cigs & vape pens permitted, but no liquid refills)
- Flags
(no staking in the ground)

Prohibitions will be STRICTLY enforced!

Festival/Venue reserves the right to deny entry or remove from the Event anyone in violation of these policies or for conduct deemed disorderly.

Other items may be refused after being deemed inappropriate or unsafe at the discretion of Festival/Venue who reserve the right to add or change rules without notice.

Any items left unattended near the entrances will be thrown away.

** These rules apply to the main Festival grounds.
Campground rules will vary to accommodate the needs of camping Festivalgoers.*

NO

- Hard-sided coolers, soft or rolling coolers larger than 12-pack size
- Outside food or beverages (except for factory-sealed water)
- Wagons, pull-carts or rolling bags, packs, etc.
- Pets
- Glass
- Metal poles
- Tents, shade canopies, or other shelter/shacks, sport-brellas, etc.
- Large beach-style umbrellas
- Inflatable items
- Drones, remote-controlled aircraft, cars or toys
- Athletic games, frisbees, footballs, etc.
- Motorcycles, bicycles, trikes
- Large chairs with rockers, side tables and/or footrests
- Golf carts or other personal transport devices (e.g. skateboards, Segways, go-peds, hoverboards, etc.)
- Inserting stakes, poles or any other objects into the ground
- Caution tape, rope, lassos
- Video and audio recording devices
- Professional cameras and video cameras
- Unauthorized vending or solicitation
- Weapons of any kind
- Drugs and drug paraphernalia
- Fireworks, explosives, flammable liquid
- Aerosol cans (sunscreen is ok)
- Large misters and squirt guns
- Laser pointers
- Abusive, foul or disruptive language and obscene gestures
- Fighting, taunting, threatening remarks or gestures
- Over-intoxication or signs of impairment related to excessive alcohol consumption
